GENERAL TERMS AND CONDITIONS :

1. Tender bids are invited for sale of scrap items (different capacities Road Milk Tankers etc.) "as & where basis" and "no-complaint" basis.
2. Bidders are advised, before participating in the tender process, they must visit the sites (Annexure-A) and contact concerned Unit person if required to verify / condition the tendered scrap materials.
3. Bidders should quote for all the scrap materials as annexed at Annexure-A. Partially quoted bidders are not considered for tender process, which leads to rejection.
4. The rates quoted (incl. GST) by the bidder is equal or higher than the base price & shall be valid up to **Six Months**. If the quoted price of the bid is less than the base price then the bid will be rejected. Any change in address of the tenderer shall forthwith be intimated to Cuttack Milk Union.
5. EMD amount of **Rs.2,30,000.00** (Rupees two lakh thirty thousand only) of successful bidder will be adjusted towards Security Deposit, while for un-successful bidders, EMD will be refunded within 30days from the date of opening of the tender on written application addressed to General Manager, Cuttack Milk Union, Mahanadi Vihar, Nayabazar, Cuttack - 4.
6. Lifting of scrap will be arranged by the party within specific time frame in consultation with the General Manager, Cuttack Milk Union. However, the bidder should be prepared to lift the accumulated scrap within 30days of the lifting schedule. The Security Deposit will be forfeited in case the selected party will fail to lift scrap materials within the scheduled period.
7. The total cost of scrap materials (including GST amount) should be deposited in **100% advance** by selected bidder at the Head Office of Cuttack Milk Union, then the bidder will be allowed for lifting of the scrap materials only within specific time.
8. The bidders shall not be allowed to clean, segregate or cutting the materials inside the Unit or Garage Premises.
9. The bidders can not transfer the offer awarded to him / her / them to others and also no sub-contract is allowed. In case of deviation of any of the conditions, the offer shall be cancelled besides forfeiting the EMD deposit amount.

SIGNATURE OF THE BIDDER

10. The Security Deposit will be refunded to the party within 30days from the date of lifting of all materials.
11. Original Money receipt / Demand Draft against tender paper cost and original Demand Draft of EMD amount and photo copies of other required documents will be submitted in a sealed envelope.

The sealed envelope wii be dropped in **Tender Box** (*laying at Head Office of Cuttack Milk Union, Mahanadi Vihar, Nayabazar, Cuttack*) duly signed and sealed in each page completing in all aspect will be considered as the property of the Cuttack Milk Union and the bidder does not right to get back the documents furnished therewith.
13. The General Manager, Cuttack Milk Union reserves the right to forfeit the Security Deposit of the bidder, who violates one of the terms and conditions of the tender document.
14. The decision of the General Manager, Cuttack Milk Union in each and every aspect shall be final and binding upon the bidder and he is the sole arbitrator for any dispute regarding the scrap sale procedure.
